- Please obey all traffic signs and speed limits. It's preferred if you ride with your lights on for added visibility on the trails, as they can be dusty.
- There are not any formally organized trail rides, but attendees are welcome to explore the area by planning a ride on their own, or with others.
- Attendees need to be especially respectful in the town of Tin Cup during the entire event. Please turn down your stereo and drive slowly!
- Do not carry extra fuel – it is a fire hazard and not necessary.
- No campfires or fireworks! Propane fire pits are permitted.
- Quiet hours begin at 10 pm in the dry camp and campground.
- There is an 8 mph speed limit in the campground.
- Most importantly, BE SAFE and HAVE FUN!

Each night there will be a Rider Rendezvous at the event tent in the dry camp. This is an opportunity to talk about upgrades to your UTVs, share stories about riding locations, and most importantly, make friends and plan rides for the following days.

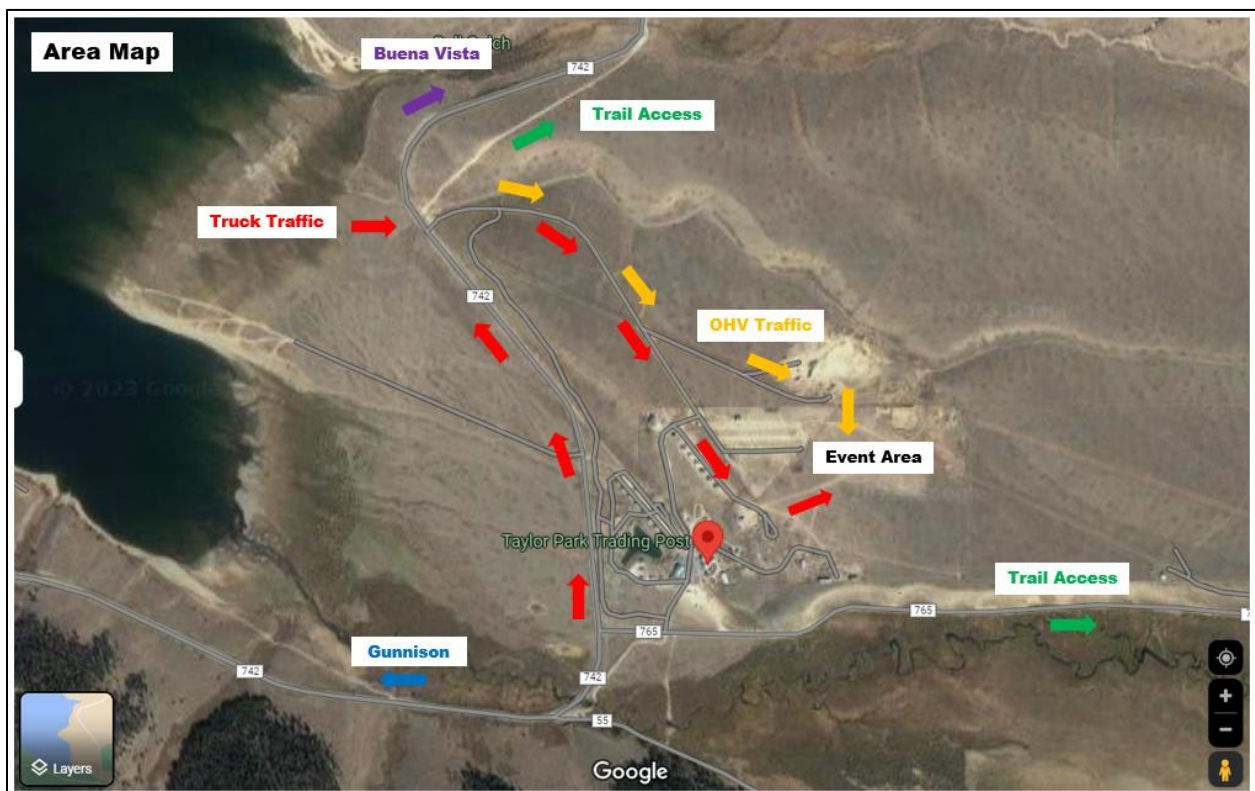
